

Guarantor Reference Form

A Guarantor would be required for an individual tenant who:

- is unable to provide a satisfactory employment reference,
- is a claimant of means tested benefits,
- has a low credit check score, CCJs IVAs DMP, Bankruptcy or adverse credit,
- has been employed for less than one year
- is in part time work.

The Guarantor:

- is usually a member of the individual's family, a friend or an employer
- is the registered owner of freehold property,
- can provide evidence of sufficient means or income (we would seek an employer's reference)
- has a satisfactory credit check score with no CCJs IVAs CMP Bankruptcy or adverse credit.

This person will be required to sign a legally binding document prior to the creation of the tenancy, which would make him/her liable for the rent and other obligations of the tenancy for the term of occupancy if the tenant defaults on their obligations. Before signing the Guarantor Agreement the Referencing form below must be completed.

REFERENCING

Once we have received your completed forms and ID we can process your application. We will carry out our references, credit checks and assemble a report for the landlord.

Whilst Rent East Yorkshire shall make every effort to keep the Tenant's personal details safe and secure, it may be necessary to share such information with trusted third parties such as the Home Office, utility companies and brokers, maintenance contractors, credit and referencing agencies and debt collection companies etc. Rent East Yorkshire will not divulge personal contact details to any other third party organisation for marketing purposes without prior approval unless this is necessary to comply with a statutory obligation.

CHECKLIST

Identification We will need to see proof of identity of the Guarantor; this can be

- either a Passport
- *or* Driving Licence & Birth Certificate.

Bank Statements You will also need to supply us with a current bank statement.

Once we have all forms, identification we can then process the application.
